This guarantee is binding upon the undersigned, their heirs, personal representatives, successors, and assigns, and shall inure to the benefit of the Seller, its successors and assigns.			
The undersigned shall pay all costs of collection, including accrued interest, court costs and repossession fees, collection agency fees, and reasonably attorney's fees. All costs of collection, including court costs and repossession fees, collection agency fees, and reasonable attorney's fees shall be considered sums owing in connection with the underlying transactions under the PACA trust, as applicable. All payments which become due under the terms of this agreement shall be made at Seller's office or at an address otherwise designated by Seller in writing. Seller may waive or release collateral or other guarantors, without notice to or consent of the undersigned.

CREDIT TERMS AND POLICY

Customer warrants and represents that all information provided in this Credit Application and Agreement ("Agreement") is true and correct to the best of Customer's knowledge. Customer acknowledges that Kekatos Enterprises, Inc. t/a Marathon Foodservice (hereinafter and above "Seller") will rely on the information provided herein by Customer in determining whether or not to extend credit to Customer. The decision to extend credit to Customer shall be made by Seller in its sole and exclusive discretion, and Seller may refuse to extend credit to Customer for any reason, or no reason at all, and at any time without prior notice to Customer, except as required by law.

This Agreement is not binding upon Seller unless approved by Seller in writing. If approved, this Agreement shall apply to all invoices or other documents evidencing Customer's obligations to Seller, all of which are incorporated herein by reference. Customer agrees that Seller is not subject to any terms and conditions set forth in any purchase order confirmation or other communication from Customer that would supplement or modify this agreement.

Customer agrees that Seller is not responsible for failure to deliver to Customer any product in any quantity, quality or price, unless noted on the original delivery receipt at the time of delivery or unless Seller is specifically notified in writing of the nonconformity within three (3) days of delivery.

Customer agrees to pay all invoices within the terms approved by Seller. Failure to remain within terms could result in the Customer's account being placed on C.O.D. terms until the entire balance is paid and may further subject Customer's account to the accrual of interest on any unpaid balance at either rate of 1.5% per month or the maximum rate permitted by law. Customer shall be liable for any deficiency after repossession and sale. In the event of default, Customer shall pay all costs of collection, reasonable attorneys' fees, court costs, repossession fees and collection agency fees. **Costs of collection, including reasonable attorney's fees, court costs, pre-judgment interest, repossession fees and collection agency fees shall be considered sums owing in connection with the underlying transactions under the PACA trust, 7 U.S.C. § 499e, as applicable.**

Customer acknowledges that Seller sends statements as part of its accounting system. Until credit is approved by Seller, all sales to Customer shall be on a cash basis. Any credit extended hereunder shall be for the names applicant only and shall not inure to the benefit of Customer's affiliates, successors or assigns. Third- and fourth-party checks will not be accepted as payment by the Seller. A \$25.00 charge shall be assessed by Seller in the event any checks are returned by Customer's bank. In the event a check is returned for insufficient funds, Customer shall pay subsequent invoices with cash or certified check only.

Seller's failure to demand strict compliance with the terms of this Agreement shall not be construed as a waiver of any Seller's rights at law or which arise under this Agreement.
